# 1 About this Document

This document defines the functional scope of the SAP Forms service by Adobe. Further restrictions may apply based on your license agreement with SAP. Functions and capabilities described in the documentation of this product may exceed the functional scope of the product to explain the integration with other SAP products, which must be licensed separately.

## 2 SAP Forms Service by Adobe: Feature Scope Description (Cloud Foundry Environment)

The service includes the following features and capabilities:

Feature	Description
Creation of print forms and interactive forms	Create print forms and interactive forms that look exactly like their paper counterparts.
Connections from cloud and on-premise applications	Use cloud applications to work with the SAP Forms service by Adobe.
Manage comments and reviews	Annotate PDF documents and collaborate on PDF document reviews.
Digital signatures	Allow users to digitally sign PDF documents.
Embedding other file formats	Embed other file formats inside PDF documents as attachments.
Pre-fillable interactive forms	Pre-fill interactive forms to save time and reduce errors.
Support of bar codes out-of-the-box	Use bar codes for your PDF documents.
PDF/A conversion	Convert PDF documents to the PDF/A format for archiving.
Support of built-in syntax checks	Use interactive forms with built-in syntax checks.
